Any part of the chicken wing maybe entered, a minimum of 6 pieces in a 9" x 9" clamshell.

Pork Loin (NOT TENDERLOIN) 6 slices or enough for 6 judges in a 9" x 9" clamshell.

Dessert need not be in a 9 x 9 clamshell but must have the

All 3 categories are open garnish. Wings/Loin may use cups of sauce, celery/blue cheese, the sky is the limit.

Desserts are encouraged to be cut/sliced (judges will be instructed to ignore slice marks and image the entire pie/cake/torte, etc)
